To: The Officials of the Directorates of Cassations, Divisions, Appellate, and Primary Courts of the Islamic Emirate of Afghanistan!

May peace, mercy, and blessings of Allah be upon you!

On 15 November 2022, the Supreme Court High Council's Session was held under the chairmanship of Shaikh al-Hadith Abdul Hakim Haqqani, the Chief Justice and the Head of the Supreme Court of the Islamic Emirate of Afghanistan. The fourth issue of the session was: ((To better regulate the activities of the courts of the Islamic Emirate of Afghanistan, the decrees of the Supreme Leader and the guidance of the Supreme Court High Council will have corresponded to all courts as circulars through Deputy of the Supreme Court and Directorate of Planning and Policy of General Directorate of Secretariate of the Supreme Court. By application of these circulars, most of the problems of the courts have been solved, so how to follow up the above-mentioned circulars?))

The High Council of the Supreme Court provided the following directions under Decision No. (4) of the Approval No. (14) dated 15 November 2022 as: ((The General Directorate of Judicial Inspection of the Supreme Court shall be assigned with the task of following up the decrees of the Supreme Leader of the Islamic Emirate of Afghanistan related to courts, orders of the Supreme Court, orders of Deputies of the Supreme Court, orders of the High Council of the Supreme Court, and circulars of General Directorate of Secretariate and other directorate of the Supreme Court that have been issued so far, and look them one by one and to pursue them whether they have been enforced or not.

In the future, the above orders and circulars shall be followed up after being issued; find out the positions and reasons for non-application of the above orders, and share its reports along with your opinion with the Supreme Court authority from time to time)).

Therefore, the instruction of the High Council of the Supreme Court has been communicated to related Directorates of the Supreme Court, Divisions, Appellate, and Primary Courts of the Islamic Emirate of Afghanistan through the above circular so that their legal/Sharia proceedings shall be carried out accordingly.
