A brief descriptive and practical plan about the Islamic Hijab

Even though, for a short period, continuous and regular programs were launched to remove the Hijab of women at the country level; fortunately, 99% of zealous and brave Afghan women kept the sharia hijab as a religious and Afghan principle and followed it. The rest must follow this mandatory ruling because there is no excuse or obstacle.

The commandment of the Hijab:

It is obligatory and necessary (Farz) for Afghan Muslim nobles and adult women to observe it.

Definition of Hijab:

Clothes that can cover the body are considered hijabs, but they should not be thin and not so narrow that they represent the body parts.

Types of Hijabs:

- Chadri, which has been a part of Afghan culture for centuries, is the best type of sharia hijab.
- The black dress and mask, known as Hijab, is also one of the religious hijabs, but it should not be tight and sticky.
- Not leaving the house without a Sharia and the necessary reason is the first and best type of observing the Islamic Hijab.

Uses of Hijab:

Those women who are not old or young in terms of age should cover their faces from Moharram, except their eyes, due to temptation.

Benefits of Hijab:

- Hijab is God's order, and observing it is obeying His command.
- Hijab is one of the privileges of Muslim women.
- Veiled women are safe from disobedience and sin, and veiled women are associated with honor and dignity.

- Veiled women are protected from the evil and corruption of corruptors.
- The conspiracies of seditious individuals and groups do not easily catch veiled women.

The method and steps of applying the Hijab:

1. Encouragement.

- Through the media and pulpits, explaining the hijab order, its importance and benefits, and the harms of not wearing the Hijab.
- Writing motivational sentences about Hijab and sticking relevant stickers in markets, parks, and public places.

2. Punishment and intimidation

- First, the house of a woman without a hijab should be known, and her guardian should be advised and punished.
- However, her guardian must be summoned to the relevant department for the second time.
- For the third time, her guardian must spend three days in prison.
- For the fourth time, her guardian must be handed over to the judicial courts to be sentenced to the appropriate punishment.
- Those women who work in organizations related to the Islamic Emirates of Afghanistan and do not wear hijabs should be fired.
- Those government officials and employees whose wives and daughters do not wear hijabs; their jobs should be suspended.
