The judiciary is independent and autonomous; no governmental authorities or non-governmental individuals have permission to interfere with judicial proceedings.

- 1. Justification: Allah Almighty says, ((ولا يجرمنكم شنآن قوم على ألا تعدلوا اعدلوا هو أقرب للتقوى)) **Translation:** And let not the hatred of others to you make you swerve to wrong and depart from justice. Be just: that is next to piety.
- 2. Justice is the administration of the commandments of Allah Almighty, which is a standard for righteousness and justice. Buildings constitute apparent, superficial, and mortal reclamation which type of reclamation is short-lived and bound to perishing.

Brief Report of the Activities of Judiciary of the Islamic Emirate of Afghanistan, 2021/2022 In the mentioned period, the High Council of the Supreme Court has convened 56 general and extraordinary sessions in which the following matters have been addressed:

In the area of inspecting review applicants: 55 matters have been addressed.

Differences in areas of authority: In this area, 14 legal, criminal, commercial, and family cases have been addressed. In the area of seeking guidance: 635 issues of seeking guidance have been answered in the light of provisions of Islam. Out of this figure, 28 points bearing general aspects have been dispatched as a circular to all courts for improved implementation of the legal provisions.

In the area of change of courts: Separate approvals in respect of 830 criminal, civil, commercial, and family cases have issues and necessary decisions adopted.

Proceedings of the 3 branches of the Judiciary In 2021/2022, 3,356 cases were in progress in the relevant divisions of the Supreme Court, 11762 cases were in progress in the Appellate Courts, and 65,319 were in progress in primary courts of the center and provinces, making a total of 80,437 cases. Of these cases, 35,092 have been settled at the primary level, 7156 cases have been settled at the appellate level, and 1382 cases have been settled at the cassation level. The remaining 43,630 cases are currently being processed in the 3 branches of the judiciary.

Receiving reports activities

Report on functions and proceedings of the courts has been and organized through video conferences, and a system for oversight of the receiving reports from courts' zones of the country for the past year has been developed. Moreover, the court proceedings' report has been heard in the High Council of the Supreme Court.

> Additionally, general inspection has, per the plan, received 41 times reports of the activities of the courts in the center and provinces in one year, out of which 73 issues have been judicially adjudicated based on instructions from the Office of the Supreme Court.

Appointment and transfer of justices

The process of appointing justices has been organized in such a way that initially, *Ulema* with professional background and specialized education in the area of justice and adjudication and equipped with devotion, sincerity, honesty, and truthfulness, are required to attend a written test followed by viva through a transparent process.

Details of the successful judge are then shared with the High Council of the Supreme Court. His appointment proposal is dispatched to the Office of Leadership in the final stage.

Capacity building

Ten academic and training programs (including Master, primary leadership skills for newly appointed heads of departments, basic computer training, procedures for professional proceedings and conduct, administrative correspondences, and recording legal and criminal entries) have been organized for personnel of the judiciary. Seventy-seven individuals participated in these programs.

Holding a training workshop titled Leadership for capacity building of heads of departments which was held in the training center for the Civil Services Institute of the Administrative Services Reforms Authority.

Fighting administrative corruption

In connection with fighting administrative corruption, 15 persons, including 1 judge, 3 administrative employees, a clerk, and 6 people associated with the judiciary, have been arrested by the Inspection Division of the Supreme Court on charges of accepting bribes, fraud, using fake documents, and stealing official documents. After preliminary investigations, their relevant cases have been prosecuted within legal provisions in time.

Cases management system Through the registration system, 5449 criminal and 8749 legal cases, with a total of 13308 cases, have been registered in the center and provinces. The process of registering cases continues.

- Proceedings of the Judiciary have been publicized for the compatriots through social media such as Twitter, Facebook, and website in their respective times.
- Similarly, video clips and interviews with various authorities of the Judiciary and individuals from the public have been developed and published.

Convening Public/Open Judicial Proceedings Open judicial proceedings have been held in many of the country's courts, particularly in courts with conference halls. All judicial proceedings have been convened publicly in the presence of the public, media, and students, complying with legal provisions.

About abolishing fees for the legal documents

- Based on the Decree from His Excellency Amir-al Momenin (May Allah protect him) of the Islamic Emirate of Afghanistan, fees for valuable documents, the fee of civil and commercial decisions, the fee of title deeds, the fee of judicial services delivery, the fee for registering applications have been abolished. All the mentioned services are now delivered free of cost.
- It is noteworthy that the judiciary has printed and distributed 15410 marriage certificates free of cost among fellow citizens.

About General • and Development Budget •

- For the year 2021/2022 (1443), the Judiciary was awarded 89,2013 Afghanis as development judgment due to budget deficit.
- For 2021/2022 (1443), the Judiciary was awarded three billion, four hundred seventy-two thousand, two hundred and 10 Afghanis as the general budget.

Similarly, in addition to constructing 8 buildings for Urban courts in the provinces and 12 buildings for district courts, the Supreme Court plans to construct one fully equipped building for the Supreme Court in the Darul Aman area in the year 2022/2023 (1444).

Recently, the administration of the Supreme Court was able to hold meetings with authorized representatives of the diplomatic missions of China and Indonesia to fund the said budget. Fortunately, they have also agreed, and after the signing of the agreement, practical work on the said projects will begin in the following years.
