

## **Islamic Emirate of Afghanistan**

### **General Directorate of Monitoring and Follow-up of Decrees and Orders Office of the Chief of Staff**

**Circular no.: 2**

**Date: 15 August 2023 (28/1/1445)**

The General Directorate of Monitoring and Follow-up of Decrees and Orders, in accordance with the mandates outlined in applicable law, has established its organizational structure for the year 1402 (2023). This structure has received approval from the Office of the Prime Minister of the Islamic Emirate of Afghanistan. Consequently, for the purpose of fulfilling the legal responsibilities and authorities, carrying out monitoring and evaluation as per the approved plan, and overseeing the legal compliance of secondary and tertiary units within ministries, independent Emirate entities, and private-sector organizations affiliated with Emirate authorities, all provincial Civil Directorates of Monitoring and Follow-up of Decrees and Orders are hereby instructed as follows:

- 1- In order to Supervise 2<sup>nd</sup> units of the ministries as well as independent Emirate entities, all the provincial Directorates of Monitoring and Follow-up of Decrees and Orders shall divide their 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> level Committees, included in the 1402 (2023) organizational structure, into sub-committees for supervision according to the index attached with this circular.
- 2- Sub-directorates of the Analysis and Follow-up of Cases of Administrative Corruption of the provincial civil directorates shall regulate their activities in accordance with sentences no. 1, 2, and 3 of paragraph 4 of Circular no. 1, dated 27/1/1445 (24 August 2023).
- 3- The sub-directorate of implementing final orders of the courts and places of deprivation of liberty shall regulate its activities according to the provisions of articles no. 8 and 9 of the Law of the General Directorate of Monitoring and Follow-up of Decrees and Orders.
- 4- Supervising the legality of detective entities and ensuring the rights of the suspects are observed in the detention centers related to the Provincial Police Headquarters and the Directorate of Intelligence shall constitute one of the obligations of the Directorate/Sub-Directorate of Monitoring and Follow-up of Decrees and Orders of Police and Directorate/Sub-Directorate of Monitoring and Follow-up of Decrees and Orders of Intelligence agencies while Supervising 2<sup>nd</sup> units of affairs of Prisons and Detention Centers in the provinces shall constitute one of the obligations of the

Sub-directorate for Supervising Implementing Final Orders of the Courts and Places of Deprivation of Liberty.

- 5- Supervising the legality of activities and Follow-up of decrees, orders, and directives at the office of the provincial governor shall constitute the appropriated duties of the civil affairs Head of the relevant province.
